Dear Sir,

We address hereby in the name of 200.000 members of our trade union, who are employed in greater state systems (JP Electro-industry Serbia, JP PTT Serbia, Telecom, a.d., JP Underground exploitation of coal, JP Public electrical network Serbia, JP Railways Serbia, JP JAT), public sector (Health, Social protection, Education, Culture, State administration and Police) and finance sector (banks and insurance companies), as well as other sectors. It is our application to you to enable Confederation, as representative social partner from Republic of Serbia, to apply for programs, projects and other activities stipulated by your organization to be realized in the course of 2011 and in future period.

Confederation of free trade unions is trade union head quarter in Serbia, founded in March 2003 in Belgrade, officially registered 2005. The founders are representative trade union of public sector: Trade union of EPS workers, Trade union PTT Serbia, Unified trade union Telecom Serbia, Trade union Telecom "Serbia", Trade union of finance organization Serbia", Trade union of workers NIS and Union of syndicates.

We inform you that, complied with Law on labour and Law on standard classification of activities, resolution of Ministry for labour and social policy, Confederation of free trade unions proved its representation on the Republic level in eleven activities: Section of elementary and secondary education, section of health protection of citizens, activity of electrical, gas and water supply, activity of ore and stone exploitation, activity of finance mediation, activity of telecommunication, activity of post and transport and delivery of items, activity of railway transport, activity of social protection, activity of library, archive, museums and other cultural activities and activity of coke production and oil derivate. However, the sufficient number of certified application forms, out of which 183.000 had been accepted, for the estimation of representation of Confederation at the Republic level, was submitted to the Ministry for labour and social policy.

However, the existing Committee for estimation of the representation supported by Minister for work has been obstructing and non-issuing the resolution on the representation.


